Chapter 2 Indices of Commenters and Index of Primary Forms

Indices are organized by commenter type, as described in Table 2-1. These indices list the comment letter numbers and titles of commenters, when provided, from federal agencies, federal elected officials, and Tribal governments (Table 2-2); state agencies and elected officials (Table 2-3); local agencies and elected officials (Table 2-4); non-governmental organizations (Table 2-5); and members of the public, including individuals who provided comments that were in part forms or petitions (Table 2-6). An index of primary forms and petitions is provided in Table 2-7. Readers should use these indices to identify the letter number or numbers associated with their submissions and then find the comment responses that are contained in Volume 3, Chapter 4, *Responses to Comments*. If a dash is shown in the table, the information was not provided or was not legible.
