

3.0 Individual Comments and Responses

3.1 Introduction

This chapter contains the comment letters received on the draft Central Valley Flood Protection Plan (released in December 2011), and the 2012 Central Valley Flood Protection Plan DPEIR. Following each comment letter are individual responses to those comments not addressed in Chapter 2.0, “Master Responses.” Section 3.1.1 describes the format of the responses to comments.
