There are two State standards for PM10, a 24-hour average of 50 micrograms per cubic meter and an annual artihmetic mean of 20 micrograms per cubic meter. Both standards are not to be exceeded.

In June 2002, the ARB lowered the State annual standard for PM10 from 30 to 20 micrograms per cubic meter.
