Good morning Robin and Scott,

We are trying to wrap up the chapters for the Sites Reservoir Project EIR/EIS by next week, and this is one of the outstanding items on the Transportation chapter. I have tried calling each of you a couple of times, but haven't heard back, so I thought I would follow-up with an email.

Contrary to my previous email, we have decided to update the baseline numbers to those which occurred in 2015. Although Caltrans publishes annual ADT for State Routes and Interstates, they do not track numbers for local roadways, and I was not able to track down the numbers for South Main Street and Diamond Avenue, which will be used to access one of the proposed Project facilities, in the Circulation Element of the City of Red Bluff's 1991 General Plan, nor the County's 2008 General Plan. If the City tracks the ADT for these two roadways, it would be great if you could provide those
