Subject: Update on planning for new Landfill in Glenn County

I called John Linhart who is the director of the Planning and Public Works Agency in Glenn County. I asked Mr. Linhart about the County plans for waste management after the closure of the current landfill which is expected on 2013.

Mr. Linhart informed me that Glenn County decided not to build a new landfill in the county and they are considering alternative options for waste disposal. The county is evaluating several options including building a transfer station to transfer collected waste to landfills in other counties, contracting with waste management companies that own or operate landfills in other counties like Yuba and Shasta, and adopting treatment technology as an alternative to landfills. Glenn County is conducting a preliminary study to evaluate anaerobic digestion facility for waste treatment.

Glenn County will make a decision on its future waste disposal operations in one or two years from now.
