As I mentioned to you over the phone, I'm working on a project for DWR and I'm looking for information on an estimate of the number of groundwater wells that supply the majority of the municipal and industrial water users in the county. I would also appreciate it if you would provide me with the range in average depth of these wells as well.

As an fyi, I have the following information (highlighted in yellow) from an earlier version of the document I'm working on. Unfortunately, the DWR document was undated though somewhere it attributes the information to the Northern District well logs.

An estimated 3,950 wells (groundwater) supply 99 percent of the municipal and industrial water demand (DWR, no date). These wells range in depth from an average of 100 to 500 feet.
