Hi, Laurie

After working on the memo it seems like Chris and Marc don't really understand why we are reaching out to other tribes; that is, they didn't realize that there are new pipeline facilities in Yolo County and that the operations of the project now include the Feather River flows. I changed what I could.

I don't have any comments on the letter, since they want to keep it minimal, which is fine with me. However, it may be useful to include a statement that the Authority has entered into AB 52 consultation with Yocha Dehe and Colusa, as it will give the tribes assurance that the Authority is working with other tribes. Otherwise, they may feel like they have to

step up and make sure that the Authority is taking tribal concerns into account. This is particularly true of UAIC, who consider it their duty to watch out for this interests of other tribes who may not have a voice.

Let me know if you have any questions. I should be more available for most of today, though I am still in Stockton until late afternoon.
