We were able to talk with Anecita shortly after you and I last talked and she is taking up the issue about the site records with DWR legal.?? Under AB 52, DWR is obligated to share such information with you, but she wants to go through legal first so that there are no negative repercussions for anyone.

??

In the meantime, the Authority would like to schedule a meeting to talk about potential ways to address impacts to significant sites?? (like using the GPR to identify burials, etc), and perhaps other ways to develop enhancements that would be important to Yocha Dehe and other tribes such as Colusa.?? We had previously discussed tribal involvement in developing trails, and I am wondering if you would also be interested in developing locations for plants used for basketry or medicinal purposes.??

In any case, we would like to continue the conversation while the site records issue gets sorted out.?? If that is OK with you, perhaps you can ask Victoria to find some dates in July; or I can reach out to her, if you??d like.
